#### INTRODUCTION

Before summer 2002, the team of Nova, Barcelona Centre for Social Innovation, presented the Call for FPH Initiatives with the proposal to undertake a collective process of reading and cross-evaluation of the "Proposal Papers" and the "Breakthroughs" published in 2001 in order to consensually produce a synthesis. The knowledge and evaluation of the proposals undertaken to date by the Allies would be fundamental for the new stage and for introducing it to other alliances and forums such as the Social Forums –World and European– or that of Barcelona 2004.

To provide around 3,000 Allies with the reading and evaluation of some 60 texts, with more than 1,000 proposals on the most varied issues, in 5 languages and at a low cost, a fairly unusual system of forums via Internet was necessary. We suggested testing the "Delibera®" system so that the Allies could participate in this process through their evaluations, comments and contributions.

In October 2002, we started the weekly publication of a Proposal Text, presented in the format of a "Delibera Questionnaire" available on the website or by e-mail and in 5 languages.

The project sought to evaluate the proposals of almost 60 texts published on the website of the Alliance ("Papers" and "Breakthroughs") in order to move towards a synthesis based on these evaluations. After 9 months and 35 texts submitted for evaluation, the FPH asked us to stop in order to undertake an evaluation of the forum and a provisional synthesis with the evaluations of the texts published between October 2002 and July 2003.

The 22 texts that remain to be evaluated, and which we hope we can process in the near future, are the following:



#### 4 Papers of the Humanity and Biosphere Pole

Energy – Time and Sustainable Development – Soil Reform – Forests.

#### 9 Papers of the Governance and Citizenship Pole

Social Leaders in the 21st Century: Challenges and Proposals – The Military – Arms Industry Conversion – Local Authorities – Fisherfolk – Farmers – Governance: Common Principles – Rights and Governance – Urban Violence.

#### 4 Papers of the Socio-Economy of Solidarity Pole

International Trade – Trade Union Movement – Health – Tourism.

#### 5 Papers of the Values, Culture, Art, Education and Society Pole

New Information and Communication Technologies – Humanity – Women – Inter-religious – Media/Journalists.

#### There also remained 2 "Breakthroughs" without Paper:

On Business Leaders and Executives about the Practice of Company Responsibilities – On Responsible Shareholders

Next we present the provisional record with the data on participation and the publication of texts.

It has been a pleasure to participate in this methodological adventure to promote and facilitate the evaluation of the Alliance proposals and especially if the results enable its members in this new stage and enrich other fields such as the Social Forums.

We are convinced that one of the factors for the non participation of many of the "historical" Allies, heads of workshops, writers of "Papers" and members of the FPH, among others, has been the lack of motivation due both to the sabbatical year of the FPH and the lack of perspectives of the Alliance. A participatory process of these characteristics, with such complexity, richness



and innovation —both in contents and in methodology— needs important incentives for it to be appropriate to those potentially interested. An incentive could have been for the results to have been presented in a determined area (e.g., the World Social Forum) and for those who had the greatest and best participation to have had the opportunity to meet in order to perfect and present a final synthesis.

Another challenge arising from this forum –and which could be another incentive for participation– is that of the collective production of alternative world models to globalisation. For the first time, a reflection process has been introduced into the Alliance on the possible and necessary articulation of proposals which until now were only thematic or sectorial.

As we have announced, before continuing with the process of evaluation and synthesis, the FPH considers it necessary to evaluate the process undertaken until now. We need to know your opinion about the evaluation and synthesis process of the proposals through the "Delibera" system. To this end, we have created a new multilingual forum <a href="http://evalua.delibera.info/gb/">http://evalua.delibera.info/gb/</a> with 3 questionnaires in which you can state your view on this first evaluation stage. Please express your opinion before 20th October 2003.

# FORUM OF CROSS-EVALUATION OF PROPOSALS FOR A RESPONSIBLE, UNITED AND PLURAL WORLD

#### 1. PARTICIPANTS

From the end of October 2002 to 22nd July 2003, 239 people from 40 countries all over the world registered in the Forum and 158 evaluated a text.

#### 1.1 PROFILE OF THE PARTICIPANTS

Many of the people who have registered in the Forum have provided a brief personal presentation and have told the remaining participants about their field of work and shared their personal motivation. We would like to thank all those who have made it possible because this gives us a better knowledge of the profile of the participants.

As we can see in the list of thematic areas that we reproduce next, the sectors of origin and motivation of those who have participated in the Forum are many and varied, although of special note is the participation of people from associations and universities.

This diversity of participation endows the evaluation of the proposals with an intersectorial character; in their turn, the statistics show a certain relation between the evaluated texts and the area of interest of the people registered. Thus, we can affirm that we had an evaluation of thematic and sectorial dimensions.

These are the sectors of interest and the professions of those registered that appear on the registration data:



AGRICULTURE.- Cultivator of medicinal plants; Sustainable agriculture; Agriculture and democracy; Head of national research laboratory on vegetal productions.

#### 1.2 COUNTRIES OF ORIGIN OF THE PEOPLE REGISTERED

Out of the 239 people registered in the Forum, 32 have not specified the country of origin. The remaining persons come from the following countries:

France, 43; Catalonia, 21; Brazil and Spain, 20 each; Argentina, 13; Belgium, 11; Colombia, 7; Peru, 5; Benin, Cameroon, Portugal, Togo and Venezuela, 4 each; Canada, Switzerland, Uruguay and USA, 3 each; Chile, Greece, India, Italy, Malaysia, Mali, Mexico and Senegal, 2 each; and one person from each of the following countries: Germany, Australia, Bolivia, Ivory Coast, Egypt, Georgia, Israel, Japan, PDR Laos, Macedonia, Morocco, Martinique, Mauritania, Moldova, New Zealand, Occitany, DR Congo, Serbia and Tanzania.

#### 1.3 CONTRIBUTIONS

The 158 participants have evaluated 912 texts between them, have written 1,145 comments and 83 new articles-proposals. In total, they represent 14,893 contributions<sup>1</sup> to the Forum.

Out of these 912 text evaluations, 685 have been made through the website and 227 re-sent by e-mail to the administrative team of the Forum, which has included them in the website.

Only 6 persons have evaluated the 35 texts; one person, 34; and the remaining, between 1 and 28 texts.

The contributions are the result of multiplying the number of evaluations made of a text by the number of ar-

#### 1.4 E-MAILS RECEIVED

During these 9 months we have received 279 e-mails, of which we have answered 205.

Some messages dealt with consultations on the evaluation system; others of congratulation for the idea of evaluating the Alliance's proposals, such as "Amigos e amigas da Aliança: Muito obrigado pelas preciosas informações que nos têm enviado. Grande abraço"; or "Estimados colegas de Alliance: Agradezco sigan enviándome estos materiales del Foro, a pesar de que no he aportado mucho al mismo, les doy utilidad para mis reflexiones laborales y personales." There were some comments on the issue of the week such as education: "De toute évidence, l'éducation est le fondement même d'une vie sociale. Les êtres humains sont, dès leur naissance, guidés par des instincts - qui sont des instincts de survivance..."; Water: "Dear colleagues, Without water there is no life. Today with water address not correctly, that can result in various sorts to diseases. The illnesses can be distributed both among the people, and among an animal and flora. It means accident. It will do to humanity very dearly..."; and also on art, food security, world governance, life privatisation and territory. Some critics on the text contents: "(SUR L'ÉDUCATION) Ce texte me semble présenter un problème dans son équilibre d'ensemble, ce qui en réduit la valeur et la portée comme base d'un dialogue constructif entre les divers partenaires intéressés par ces enjeux." There were also comments on the lack of time to evaluate the proposals despite the interest that they awaken, e-mails announcing that the addressee is temporarily absent, etc.



#### 2. TEXTS

During 9 months we have published the 35 texts in 5 languages -Spanish, Catalan, French, English and Portuguese- and at a rate of around one per week in "Delibera Questionnaires" of the corresponding "Proposal Papers" and "Breakthroughs" of the Alliance. Each week we have sent an e-mail to the 5 lists, according to language, announcing the release of a new text and enclosing the corresponding evaluation questionnaire and the "Desirable News" with those proposals that had their "News" published.

#### 2.1 PUBLICATION OF THE TEXTS

Some texts have been released based on the "Breakthroughs" and some others on the summaries of the "Proposal Papers" that appear on the Alliance's website: <a href="http://www.alliance21.org/en/proposals/">http://www.alliance21.org/en/proposals/</a> We have processed a total of 521 pages of original texts, collected into 517 articles. The publication work has consisted of the reading of the texts, selection of the "Breakthroughs" or the "Papers" for the writing of the questionnaires, writing of the introductions and translations of all the texts into Catalan and the other languages in which they had not been translated in order to put the content of the original in a format suitable to be evaluated with the "Delibera" icon system:



In all cases we have respected the text written by the author (although sometimes the translation was not very intelligible), almost without modifying the original writing. Only in the cases when the summary was too long have we abridged it, trying to summarise the most significant ideas. In two cases, we have united more than one proposal in a single questionnaire, given that their contents complemented each other and allowed a joint evaluation; these are text 01, which brings together the "Breakthroughs" of



the Scientists Network and the Workshop on Scientific Production, and number 20, which brings together three "Papers": Food Security and Sovereignty, Sustainable Agriculture and WTO and Agriculture.

In each questionnaire we have provided information on the origin of the text and the original languages in which it was written and we have included the link to the original text of the Alliance's website in order to facilitate access to the complete proposal and the "Desirable News" if this exists.

#### 2.2 TEXTS WHICH HAVE AWOKEN GREATEST INTEREST


Given that this is a periodical publication, from the release of the first text to that of the latter 39 weeks have passed. Thus, the first text has had an evaluation period of 38.8 weeks and the latter of 1.7. We have born in mind this variable when estimating which texts have been most evaluated, together with another factor: the curve of participation increases during the first 4 weeks of the release of a text, it ascends slightly until week 20, then becomes more or less stable and grows during the ninth months coinciding with the announcement of the closing of evaluations for the first synthesis and its possible presentation to the next Social Forums.

#### 2.2.1 Expectation of Evaluation

Bearing in mind the evaluation behaviour of the first texts released, one obtains a curve of "expectation of percentage evaluation". This curve has helped to undertake an approximate calculation of evaluations of each text if this had the same publication period as the first. The resulting number is called "expectation of evaluation" and we consider that those texts which have achieved the highest evaluation of this number are the most valued.



### Curve of the Expectation of Evaluation



Values 1, 3 and 4 are the evaluation behaviour in the publication time of three texts chosen as a sample for the curve calculation.



#### 2.2 CRITERIA FOR THE SYNTHESIS

The proposals were written in articles to facilitate a simple evaluation similar to how legislative texts are evaluated. Since the articles are conceived and written as self-sufficient elementary propositions, in terms of their content, it allows a very wide range of combinations between the articles, it being possible to obtain in each combination a new text. In this way, through the isolated evaluation of each article, we will be able, in the end, to obtain a conceptually coherent synthesis that groups the most favourably evaluated elementary proposals.

A **first synthesis criterion** with respect to the most favourably evaluated proposals has been the thematic grouping. In this sense, we have made 4 large thematic groups which are the Alliance's Poles for a Plural, Responsible and United World: Humanity and Biosphere; Socio-Economy of Solidarity;



Governance and Citizenship; and Values, Culture, Art, Education and Society. The synthesis allows us to obtain 4 new texts of proposals on the general problematic of each pole with a large degree of consensus on the contents.

A **second synthesis criterion** has been the construction of a cross-proposal for an alternative model to neo-liberal globalisation. This has been possible based on the latter article aggregated to all the texts referring to global evaluation. Following these lists of proposals made in the comments on the latter, we have managed to extract the most favourably evaluated elementary proposals for an alternative global proposal.

#### On the Number of Proposals of each Synthesis

From the point of view of the syntheses presentation, we have considered it appropriate to make texts of around 30 articles.

Given that, for the time being, we have not managed to submit for evaluation the 57 planned texts but only 35, we are facing the problem that there is a highly unequal number of evaluated proposals belonging to each Pole. Consequently, the number of articles to be selected in each text has varied according to the number of texts submitted for evaluation in the corresponding Pole. Thus, we have 8 texts from the "Values, Culture, Art, Education and Society Pole"; 15 texts from the "Socio-Economy of Solidarity Pole"; 5 texts from the "Governance and Citizenship Pole"; and 7 from the "Humanity and Biosphere Pole".

#### On the Synthesis of each Pole

A first criterion for the selection of articles has been to guarantee the greatest thematic scope of the synthesis of each pole establishing that, in all cases, the most favourably evaluated article of each text was included in the synthesis.



A second criterion for the selection of articles was to take all those most favourably evaluated texts which did not contain any red evaluation in order to select articles on which there was no disagreement. In the case of the most favourably evaluated article having a red evaluation, the previous criterion has been modified and the second article of this text has been selected in order to guarantee the thematic scope of the synthesis. This criterion has involved making an exception with proposal "12. Economy of Solidarity", which has been evaluated in red in the totality of its articles. However, none of these red evaluations has a clarifying comment and even the red evaluation for the last article of the world evaluation is accompanied by a approving comment for several articles as valid for an alternative global proposal. Moreover, the most favourably evaluated article of this proposal has 30 green evaluations, none yellow, none black and one red without explanation. We have no record of disagreement, either partial or total. It seems as if a participant has made a mistake when using the telematic tool and has placed a red evaluation in all the articles but this does not mean that she/he was against.

A third criterion for the selection of articles has been to consider as most favourably evaluated those which, with an equal number of green evaluations, had been more evaluated. This also means that a proposal which has yellow and black evaluations may be more favourably evaluated than another which has all the evaluations green given that the first has more evaluations and may even have more green evaluations than the second. In this sense, it was necessary to solve the fact that there is a great imbalance in the number of evaluations between the different texts, which must be interpreted as a more favourable evaluation of the proposal that prompted greater participation. Thus, an article with all the evaluations in green but which amount to a total of 14 must be less favourably evaluated than another article with 5 yellow and 4 black but which has 44 green. The idea is that if the quantity of evaluations was homogenised for all the texts from the same pole, taking into consideration the text with the greatest number of evaluations, then to the articles of the texts which have less favourable evaluations should be added black evaluations (default vote in the "Delibera" system).

A fourth criterion for the selection of articles, applicable in the cases of an absolute tie in the evaluations, has consisted of selecting according to the



content, in function of the contents of the general synthesis, remembering to avoid reiteration of contents with other selected proposals.

A fifth criterion for the selection of articles is related to the selected articles according to the former criteria that have a similar content. In this case, the most favourably evaluated article of the two of equal content is selected and the other is suppressed and substituted with any other article which meets the preceding criteria.

A criterion for the selection of new suggested articles has consisted of selecting those which widen the thematic content of the text with a concrete proposal which is not opposed to the articles selected as most favourably evaluated. This is due to the fact that there was no evaluation by the participants of these articles and, therefore, it would have no meaning to include in the synthesis proposals that in themselves involve disagreement. In some cases, the selection of a new article has been made by rewriting or selecting a part of a comment by a participant.

Once the 30 most favourably evaluated articles for each Pole and the new suggested articles that widen the proposal have been selected, the sequence of presentation in the Cross-Synthesis of the Pole does not follow an order of evaluations of the articles or the numeric sequence in which the proposals to be evaluated were presented but rather an expositive order according to the content so that the cross-synthesis is coherent. At the end of each article, on a brief numeric table is the number of opinions collected in the evaluation when starting the synthesis in July 2003.

#### On the global cross-synthesis

30 articles from the 35 texts that participants considered in each text "key proposals for the preparation of alternatives to the current globalisation model" have been selected.



#### 3. COSTS OF THE FORUM

The design and co-ordination of the Forum team during a year; the setting in motion of the methodology for the production of texts with articles based on not very homogenous "Proposal Papers" and "Breakthroughs"; the translation and publication in 5 languages of 35 texts; the revision and creation of a mailing of the questionnaires in 5 languages with 158 participants and more than 14,000 contributions (evaluation of articles, comments, new proposals, etc.); plus the preparation of this record and the provisional syntheses has amounted to 57,230 €, a little less than the cost of two conventional electronic forums on an issue, with moderator and revised automatic translation. The cost of the "Delibera" system (35 texts x 5 languages: 175 forums) including the hosting has been, to date, a contribution of the company Serveis de Participació Interactiva SL, which has developed the system and has registered the trademark "Delibera".

#### 4. WORK INVOLVED IN CREATING THE FORUM:

The team for the promotion of the Forum, formed by a director, advisor, writer, translator and administrator, have devoted to this part of the Forum a total of 2,294 hours divided into the following tasks:

PREPARATION OF THE FORUM -453 hours

Design and planning of the project; study on "Breakthroughs" and "Papers"; team meetings; preparation of work documents; design of questionnaires and links; adjustment of the "Delibera" website to Propalliance.



#### PUBLICATION OF TEXTS -1,551 hours

**Publication based on the "Breakthroughs"**: reading and revision of the "Breakthroughs"; writing for the "Delibera" system; translation of the introductions into 5 languages; translation of the questionnaire into Catalan.

**Publication based on the "Proposal Papers":** reading and revision of the apertures; writing for the "Delibera" system; translation of the introductions into 5 languages; translation into Catalan of all the texts; translation of the texts which do not have a Paper translated.

**Management and layout:** Layout of Word to enter the text in the questionnaire (in 5 languages); layout of Word to enter the text in "Delibera" (in 5 languages); entry of the texts to the Forum (in 5 languages); preparation of PDF for the news.

Mailing and moderation of lists: design of the weekly text and translation into 5 languages; preparation of e-mail with the linked archives and mailing to the 5 lists; moderation of the Forum via Internet and management of e-mails and mailing lists; entry of the evaluations of the questionnaires received; periodical preparation of statistics of participation.

#### FINAL SYNTHESIS -290 hours

Collection of data of the evaluations, comments and new articles; writing and translation of the contributions of the participants for their incorporation into the texts; establishment of criteria for the election of the most favourably evaluated articles; writing of the 4 cross-syntheses of the poles and the global cross-synthesis; collection of data and calculation of the statistics of participation; writing of the record; translation into French and English of the synthesis and the record.
